**Will power be provided?** *Yes, each vendor will be provided with (2) 120-V (15 AMP) electrical outlets. We suggest you have at least 100 feet of extension cord for any of your electric items.*

**Will you have pizza warmers on-site?** *Yes, we will have standing warmers with capacity to keep your on-site product warm and fresh for up to four hours. These warmers will be stationed in between vendors for multiple use. You are also permitted to bring your own warmers.*

**Will we be able to re-supply Pizza?** *Yes, each vendor will receive a delivery pass and be allowed to refill via the outlined yellow delivery lane. This lane will remain open for vendors to resupply fresh product throughout the day.*
